A Word From the President

The 9th Polish Institute of Arts and Sciences of America's World Congress has just concluded. This time we met at the Collegium Civitas in the Palace of Cul-

ture in Warsaw under the patronage of the Minister of Science and Higher Education and with the presence of many important guests, including Warsaw Mayor Rafał Trzaskowski. On Saturday, June 8, Robert Kostro hosted our banquet at the Polish History Museum. With 54 panels and over 180 participants from 17 countries, the Congress was another testament to the dedication and hard work of all board members, especially outgoing PIASA president Robert Blobaum, executive director Bożena Leven, and program conference coordinator Patrice Dabrowski.

Let me then begin by saying a big thank you to all who participated in the Congress, but especially to Robert

Blobaum, whose second term as PIASA's president has just ended. Bob, under your unwavering leadership, PIASA organized one of its most successful Congresses. Thank you!

I am tremendously honored to be the next president of PIASA. I am grateful for the trust of the PIASA Board and for Bob's guidance over the last year, which has helped me to prepare for this new role. Bob's leadership over the last six years has transformed PIASA into a robust organization with growing recognition worldwide. I am stepping into big shoes.

Growing up in Communist Poland, I could have never imagined that this honor—the opportunity to head a major Polish/Polish American organization—would be part of my experience as well. I was born and raised in Gdańsk, Poland. For the past 20 years, I have lived in the United States, moving from Indiana, through Florida, to Michigan. I completed my Ph.D. dissertation in Eastern European history at Indiana University. In 2007, I moved back to Gdańsk, where I had the chance to work at the Second World War Museum. In 2011, I returned to the United States, first to work at the University of Florida in Gainesville, and then at the University of Michigan-Dearborn,

> where I am Frank and Mary Padzieski Endowed Professor in Polish/Polish American/Eastern European Studies. Before becoming involved with PIASA, I served as the president of the Polish American Historical Association (PAHA) from 2018-2020. I am the author of If the Walls Could Speak: Inside a Women's Prison in Communist Poland (Oxford University Press, 2018) and An Ordinary Life? The Journeys of Tonia Lechtman, 1918-1996 (Ohio University Press, 2022). Despite being firmly entrenched in American academia and my local Detroit community, I have always kept one foot in Poland, returning there on grants, participating in various projects and conferences, and publishing in Polish. I believe not only in the importance of main-

taining these contacts but also in building bridges for colleagues and students from both continents to meet, share, and grow together. And I firmly believe that PIASA is becoming one of the most important spaces for collaboration and recognition of people whose work is connected with Poland and/or American Polonia.

PIASA stands strong: It includes participants from many countries, continues attracting new people (including junior scholars from both Poland and the United States), contributes to academic discussions by organizing conferences and running *The Polish Review*. It is an important platform for recognizing the work of Polish scientists and scholars. It is inclusive, open, and forward-looking. As the incoming president, I am eager to continue building on this strong foundation.

The Ninth World Congress on Polish Studies

On June 7-9, 2024, the 9th World Congress on Polish Studies, organized jointly by the Polish Institute of Arts & Sciences of America and Collegium Civitas, was held in Warsaw. This year's theme of "Poland in the World" seems to have struck a chord. The congress was international demographically as well as thematically: the 186 panelists represented 18 countries in Europe, North America, Asia, Africa, even Australia.

The congress took place at Collegium Civitas, in Warsaw's historic Palace of Culture and Science. It was a perfect venue for the congress. Many thanks to Collegium Civitas colleagues Agnieszka Mrowińska, Katarzyna Maniszewska, and Maciej Krzyczkowski for all they did to make the congress a success. They likewise arranged for numerous Collegium Civitas students to serve as volunteers throughout the conference. Members of the organizing committee from PIASA were Robert Blobaum, Bozena Leven, Anna Müller, Neal Pease, and Patrice M. Dabrowski. The last two served as program co-chairs.

Prior to the official opening of the conference, a wellattended excursion through the Warsaw district of Praga took place on Thursday afternoon. Participants were shown how the historic yet long ignored district is now getting greater attention and development, as seen through the transformation of the former vodka factory into a multipurpose center for tourists and locals alike.

The plenary session on Friday morning was filled not only with participants but with Polish dignitaries; the latter were greeted by name by our gracious host, the Rector of Collegium Civitas, Stanisław Mocek. His words of welcome were followed by those of Warsaw's Mayor, Rafał Trzaskowski, who is also a lecturer at Collegium Civitas, and whose off-the-cuff remarks were very well received.

The congress was organized under the honorary patronage of the Minister of Science and Higher Education, Dariusz Wieczorek. We are honored that the Undersecretary of State at the Ministry of Science and Higher Education Andrzej Szeptycki came to the plenary session and greeted those present.

Our plenary speaker was Deputy Minister of Foreign Affairs Władysław Teofil Bartoszewski, who spoke on the theme "Poland in the World."

The conference proper was composed of some 54 panels on a wide variety of topics, ranging from premodern history and literature through the most contemporary assessments of European security. There were a number of panels of a historical nature, among them quite a few dealing with women's history and Polish-Jewish history. Migration studies were also richly represented. Papers were given about theater and film, prose and poetry; and Polish-American and other topics related to the Polish diaspora around the world also figured in the mix.

Five panels featured the winners of some of PIASA's 2023 awards. Professor Larry Wolff of New York University was feted as recipient of the Susanne Lotarski Distinguished Service Award; a scholar of Eastern Europe, the Habsburg Monarchy, the Enlightenment, the histories of childhood and opera, he explained how his encounter with Polish Studies-including his early work under Harvard Professor of Polish Literature Wiktor Weintraubinfluenced his research trajectory. The Halecki Book Award winner and runner-up, Małgorzata Fidelis and Kyrill Kunakhovich, respectively, shared a podium, their two books dealing with overlapping themes. Likewise in the spotlight were the two co-winners of the Rachel Feldhay Brenner Book Award in Polish-Jewish Studies, Yechiel Weizman and Geneviève Zubrzycki, for their respective monographs. Tomasz Zarycki was celebrated as the winner of the Malinowski Book Award. The Cienciala Book Award panel, with co-editors Irena Grudzińska Gross and Konrad Matyjaszek, inspired a lively discussion on the "New School of Polish-Jewish Studies." Unfortunately Vitalii Borymskyi, the winner of the Krzyżanowski Award for the best article in our flagship periodical The Polish Review, was unable to leave Ukraine to receive his award and participate in person at the congress.

Another highlight of the congress was the awards ceremony and banquet, held in the imposing building of the brand new Museum of Polish History, on the site of the Warsaw Citadel; it is so new that the permanent exhibit is still under construction. The evening began with a lively talk by Janusz Onyszkiewicz on "25 Years in NATO: The Role of Poland in the Transatlantic Community." Witness to the early strivings of Poland to join NATO, Dr. Onyszkiewicz covered that early period through to today's more central role for the country, given the Russian war against Ukraine. Next, awards were handed out, after which the group adjourned to the rooftop for a look at the Warsaw skyline before heading back indoors for the banquet. Much good food, wine, and conversation was to be had. We are grateful to museum director Robert Kostro for his generous hospitality.

Presiding over Friday's plenary session and the Saturday evening awards ceremony was PIASA president Robert Blobaum. These were his final public tasks as president: in July he hands over the reins to Anna Müller. We all owe Bob thanks for his steady and inspired leadership these past six years, which have been some of the most dynamic years of the institute.

The consensus regarding the level of the panels was extremely positive, numerous participants expressing their thanks to the organizers. Perhaps that will translate into more applications for next year's conference, which is scheduled to be held in New York City at Columbia University next June. We hope to see you there!

The Fulbright Program is accepting applications from U.S. scholars for the following programs: (1) Scholar Awards for researchers at all career levels. Location and eligibility vary across all awards, and some awards may be restricted to certain career levels or types of scholars. This information is outlined in the award description; (2) Distinguished Scholar Awards open to those with more than seven years of experience in their discipline or area of expertise; (3) Postdoctoral Awards for recent graduates to conduct research and receive professional training abroad; and (4) International Education Administrator Awards for education professionals and senior higher education officials. University of Michigan Visiting Fellowships for Polish Scholars

The University of Michigan is seeking applications for its **Dianne Widzinski Visiting Fellowship for Polish Scholars**. Applicants are invited to propose research projects that could include, but are not limited to: rule of law or topics of vital importance in contemporary Poland, freedom of speech, women's rights, issues of equity and social issues in Poland. Candidates must have current residency in Poland and possess excellent oral and written English language skills; proficiency will be verified. There are two awards available as follows:

Widzinski Senior Fellows: A three- to nine-month residential fellowship for scholars, artists, journalists or public figures from Poland to pursue their research, art or mission while engaging with U-M students, faculty, and the Michigan community. Engagement may consist of public lectures and participation in CCPS events. The specific term of residency will be designed with the CCPS director. Awards include round-trip economy class airfare to Detroit, Michigan; health insurance coverage; reimbursement for visa fees; and salary commensurate with academic rank or experience.

Widzinski Research Fellows: A one- to three-month residential fellowship for advanced Polish doctoral students conducting research in Polish studies. Awards include round-trip economy class airfare to Detroit, Michigan; health insurance coverage; reimbursement for visa fees; housing; and a stipend.

Applicants must submit a completed application form including:

- A brief proposal (approximately 1,000 words) describing: a) past and current research, and b) plan for the visit at U-M
- Curriculum Vitae
- A copy of your doctoral diploma or highest degree received
- Widzinski Research Fellow applicants must also submit a recommendation letter from the dissertation chair or comparable or person with excellent knowledge of the candidate and their work
- Consent to participate in interview via telephone, Skype, or Zoom

Maria Zakrzewska was honored by the Chicago Public Library as "a tireless champion of initiative to create services to connect Chicago's Polish community with the public library" and was also featured in an article in the Chicago Dziennik Związkowy February 3-5, 2023, and the Polish American Journal of March 2023. In 2023 she worked with Ewa Modzelewska-Opara of the Jagiellonian University in Kraków to help publish a translation of The March prepared by Księgarnia Akademicka in Kraków. She also published her own book, Stanisław Wokulski i Tomasz Judym. Małość i heroism (Kraków: LIBRON, 2023). Her review of Ewa Barczyk's Footprints of Polonia appeared in the December 2023 issue of Pamiętnik Literacki in London and her article "The History of the Polish Collection and Programming at the Chicago Public Library" appeared in The Polish Review, Vol. 69, no. 2 (2024), 68-88. She also continues to be active organizing meetings as a vice-president of the Kosciuszko Foundation, Chicago Chapter.

Justyna Zych presented "Lower Silesia in Olga Tokarczuk's and Joanna Bator's Literary Work" at the 9th World Congress on Polish Studies in Warsaw in June.
