HOW TO SUBMIT ARTICLES: Manuscripts should be submitted in Microsoft Word via e-mail attachment to the Editor, Halina Filipowicz, at hfilipow@wisc.edu. The length of each article submission should be 7,000 to 9,000 words including notes, tables, etc. Each manuscript should include an abstract of approximately 250 words plus five keywords. Manuscripts are evaluated in a double-blind peer-review process on the basis of their originality, the scope of research, and the clarity of the thesis, presentation, and conclusions.
