## A Word From the President

One of the initiatives PIASA is particularly pleased to support this year is the project “Biography and Academic Imaginarium. The Polish Intellectual Diaspora in the Autobiographies of Scholar-Migrants (BRAINY),” funded by the National Science Centre (NCN) under the supervision of Prof. Kamil Łuczaj. Many PIASA members know first-hand the extraordinary value of autobiographical memoirs as historical sources. Scholars have relied on them to understand not only historical events but also the everyday experiences, hopes, anxieties, and aspirations of ordinary people. These memoirs exist because, more than a century ago, Polish sociologists such as Florian Znaniecki, Józef Chałasiński, and Ludwik Krzywicki recognized something profound: if we want to understand society, we must allow people to speak in their own voices.



The memoir competitions they organized became one of Poland’s most original contributions to the social sciences. They invited peasants, workers, the unemployed, young people, and emigrants—groups whose lives had rarely been preserved in written form—to tell their own stories. The resulting collections transformed not only Polish sociology but also the broader practice of qualitative research. The lesson these memoirs teach is that history is not created only through great political events or famous names. It is also built from individual lives—lives that often seem ordinary while they are being lived.

As I learned from Dr. Monika Jania-Szczechowiak, one of the scholars leading the project, BRAINY seeks to continue this tradition by inviting scholars who migrated from Poland between 1990 and 2025 to share their autobiographical accounts. Academic mobility has always been part of scholarly life, enabling the exchange of ideas

## 10th World Congress of Polish Studies

On June 12-13, 2026, the 10th World Congress on Polish Studies of the Polish Institute of Arts & Sciences of America was held in Lublin, Poland. Our gracious hosts were the Institute of Social Communication and Media Sciences of Maria Curie-Skłodowska University (UMCS) and the Institute of Central Europe. The city proved to be a perfect match for the theme “Crossroads of Cultures.” The Congress was international demographically as well as thematically: over 150 panelists represented 10 countries in Europe, North America, and beyond.

The Congress took place at the Institute of Social Communication and Media Sciences of Maria Curie-Skłodowska University. It proved to be an excellent and welcoming venue. Many thanks to organizing committee members Agata Fijuth-Dudek, Iwona Hofman, and Sławomir Łukasiewicz for all they did to make it a success. Numerous UMCS students served ably as volunteers throughout the Congress. Members of the organizing committee from PIASA were Anna Müller, Bożena Leven, Neal Pease, and Patrice M. Dabrowski. The last two served as program co-chairs.

Prior to the official opening of the conference, a well-attended three-hour excursion through the old town of Lu-

across borders. Yet behind every academic CV lies a much richer story: decisions to leave, moments of uncertainty, intellectual discoveries, encounters with new cultures, experiences of belonging and displacement, and both success and disappointment. These stories rarely appear in our publications, yet they profoundly shape who we become as scholars. As Dr. Jania-Szczechowiak explained: “Every story is unique, and every biographical experience is unlike any other. Our hope is that these ‘new memoirs’ will continue the history of academic migration and that the experiences and reflections they preserve will help build an academic world free from prejudice and inequality.”

I encourage members of our community to consider participating in this initiative. We often spend our careers preserving the histories of others. Occasionally, we are also called upon to preserve our own.

Lublin took place on Thursday afternoon. Our guide from the NN Theater at the historic Grodzka Gate taught us much about the Jewish side of the prewar city and how it is being remembered even today. This part of the excursion was followed by a visit to the stunning Gothic Holy Trinity Chapel and the National Museum on the grounds of Lublin Castle.

The plenary session held on Friday morning was filled not only with participants but with a number of Lublin dignitaries: the heads of the two host institutes, the prorector of UMCS, and the deputy mayor of Lublin all had kind words of welcome. Official patrons of the Congress included Marcin Kulasek, the Minister of Science and Higher Education; Radosław Dobrowolski, the Rector of UMCS; the Committee of Sciences on Social Communication and Media Sciences at the Polish Academy of Sciences; and Krzysztof Żuk, the mayor of Lublin.

Our plenary speaker was Prof. Monika Adamczyk-Garbowska, who spoke engagingly on the topic “A Holy City, a Cursed City: Lublin in Jewish Collective Memory.”

The conference proper was composed of 42 panels on a particularly wide variety of topics ranging from gender studies, history, and literature through media studies and contemporary assessments of Central European security. Several panels focused on multicultural dimensions of Lublin. One fascinating perspective came from the local civil society activists whose engagement with Ukrainian refugees after February 24, 2022, earned their city the name of “Rescuer City.”

A full six panels featured the winners of some of the 2025 PIASA awards. Jan Tomasz Gross of Princeton University was feted as recipient of the Lotarski Distinguished Achievement Award, acknowledging his lifetime of path-breaking achievement. The Halecki Book Award winner and the Brenner Book Award winner, Jacob Flaws and Waitman Wade Beorn, respectively, shared a podium, their two books dealing with World War II death camps (Treblinka and Janowska, respectively). Agnieszka Pasieka won the Malinowski Book Award for her timely and telling anthropological research on far-right youth activists in today’s Europe. Likewise in the spotlight was the Lednicki Book Award winner, Anna Parkitna, for her work on opera in seventeenth-century Warsaw. Honorable mention was awarded to Elżbieta Ostrowska for her study of the films of Agnieszka Holland. A panel devoted to the second honorable mention, Karen Underhill’s *Bruno Schulz and Galician Jewish Modernity*, unfortunately had

to be cancelled. We hope to organize a discussion of the book in the fall, to be posted on PIASA's YouTube channel. Anna Husarska and Leszek Jażdżewski were celebrated as co-winners of this year's Pilarczyk Foundation Award to Promote Democracy and the Rule of Law.

Another highlight of the Congress was the awards ceremony and banquet, held at the university. After hors d'oeuvres, soup, and main course, awards were handed out to the winners present—and nearly all awardees came for this festive event—by PIASA president Anna Müller and past-president Robert Blobaum. The evening ended over dessert with a well-illustrated talk by Jacek Kołtan on “Why Solidarity Matters? A European Idea and Its Political Promise.”

The general consensus regarding the level of the panels and the Congress overall was positive, numerous participants expressing their thanks to the organizers. Hospitable Lublin invites us back to celebrate its status as European City of Culture in 2029.

One hopes that the positive assessments of the Congress will translate into numerous applications for next year's conference. A departure from our usual pattern, it is scheduled to be held June 11-12, 2027, in a city and country that have yet to host a PIASA event: Berlin, Germany. We will be the guests of the West Slavic section of the Department of Slavic and Hungarian Studies at Humboldt-University Berlin. Preparations have already begun. We hope you will consider joining us there.

## Call for Applications Holocaust Studies

The Mandel Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum is accepting applications for the Moskowitz/Rafalowicz International Research Workshop Global Geographies of the Holocaust: Mapping Jewish Refugee Resettlement. **Deadline is July 17, 2026.** Applications must be submitted in English at [ushmm.org/research-workshops](http://ushmm.org/research-workshops). The workshop is scheduled for two sessions, October 5–7, 2026 and July 26–30, 2027, in Washington, DC. It will focus on resettlement projects for Jewish refugee relief from Hitler's Europe between 1933 and 1945. The October 5–7 session will meet to collectively define the project's scope, theoretical framework, and the structure of its dataset. The

July 26–30 session will refine the structure of the dataset and provide participants opportunities to conduct research in the Museum's collections and other archives in Washington, DC.

## Call for Nominations Independent Scholars

The Association for Women in Slavic Studies is accepting nominations for the Mary Zirin Prize. The award of \$500 is for an independent scholar working in Slavic or Central and Eastern European Women's Studies. Nominations are particularly encouraged, but not required, for scholars working in women's or gender studies at any career level. Nominations are welcomed from Central and Eastern Europe and from Eurasia. Nominations must include: (1) a nomination letter, no more than two pages long, double-spaced; (2) the nominee's updated curriculum vitae; and (3) a sample publication (e.g., article or book chapter). The nomination letter should describe the scholar's contribution to the field, as well as work in progress. 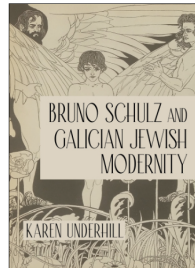

The article provides a condensed completion to the biography of Bierzyńska’s early years, *Warsaw Is My Country: The Story of Krystyna Bierzyńska, 1928-1945* (Academic Studies Press, 2018). She also gave a talk at the 10th World Congress on Polish Studies, June 13, on the panel Polish Women in Motion: Migration, Memory, and Cultural Lives Across Borders. It was titled “Warsaw, Hollywood, ???: The Shifting Ambitions of Polish Film Actresses after the First and Second World Wars.”

**Christopher Kasperek** published his English translation of Józef Kasperek’s book *My Wars*, recounting the author’s role in Poland’s October 1938 *Akcja Lom* (Operation Crowbar) covert action that eliminated the German-backed Ukrainian-nationalist *sich* that had posed a threat to southeastern Poland’s minority-Polish population and that restored Carpathian Rus to Hungary, thus enabling the Polish government, 85,000 Polish troops, and the Polish Cipher Bureau’s mathematician-cryptologists, who had been reading German Enigma ciphers since December 1932, to escape abroad in September 1939 and continue their war at the side of Poland’s western allies. It includes Kasperek’s experiences in the September 1939 Campaign, his six-month interrogations by the Soviet NKVD, and his subsequent experiences in Soviet forced-labor camps until Germany invaded the USSR in 1941 and the Polish Army’s Second Corps was formed and evacuated to the Near East. It also details the purchase, by Kasperek’s immediate unit, of the celebrated soldier bear, Wojtek.

**Timothy Kearney** was promoted to Associate Professor at Centenary University in Hackettstown, New Jersey.

**Paul W. Knoll** chaired a session at the annual International Congress on Medieval Studies, Western Michigan University, Kalamazoo, Michigan, on May 15 devoted to the memory of the great Czech medievalist and historian of the Hussite movement, František Šmahel.
